Zone 4 – Friends of Education Award

Background

The Friends of Education Award recognizes organizations in the community who have made a special contribution to education in Zone 4.

In the event the nomination should qualify for a provincial ASBA Award, the award committee will forward the nomination to the ASBA.

Criteria

This service must be documented and most importantly, be regional in character. The major criterion for the Friends of Education Award is a significant contribution to education in Zone 4. Nominees should be demonstrably committed to the improvement of education in Zone 4 students.

Procedural Guidelines

Nominations for the Friends of Education Award are by board motion. Boards may nominate an organization outside their own jurisdiction.

The Zone 4 Awards Committee will review the nomination forms, may conduct selection interviews and will select the winner.

The Chair of the Award Committee will notify the winner within two weeks of Zone 4 making its decision.

The committee is responsible for buying an appropriate gift to be presented at the September Zone 4 meeting.

The Chair of Zone 4 will present the gift.

It is recommended that each Zone 4 representative inform his or her Board of this award by December.

Awards Presentation

A Zone 4 Friends of Education Award will be presented by the Chair of Zone 4 to the recipient at the Zone 4 September Meeting.
